SUBJECT: Emergency rules

The board will be meeting next week in a special meeting to consider whether to adopt 21 NCAC 06N .0119 as an emergency rule. To assist the board with its deliberations, this memo explains the legislative background, rule provisions, and procedures for adoption.

Legislative background

On October 25, 2024, the governor signed Senate Bill 743 into law. The law was chaptered as Session Law 2024-53. The purpose of the bill was to offer disaster recovery and assistance to individuals and communities affected by Hurricane Helene.

Among other provisions, the legislation authorizes state agencies to exercise regulatory flexibility for employment-related certifications, including the sort of licenses that the board issues. Specifically, the legislation requires agencies to do all of the following if "it is in the public interest, including the public health, safety, and welfare and the economic well-being of the citizens and businesses of the affected area":

- Delay the renewal dates of employment-related certifications issued by the agency pursuant to its statutes for residents of the affected area; and
- Delay or modify any educational or examination requirements for employmentrelated certifications implemented by the agency pursuant to its statutes for residents of the affected area.

The legislation allows agencies to adopt emergency rules that expire March 1, 2025, to implement this regulatory flexibility. It also requires agencies to report by March 1 to two legislative bodies—the Joint Legislative Administrative Procedure Oversight Committee and the Joint Legislative Commission on Governmental Operations—on how the agencies used this regulatory flexibility.

Rule provisions

The proposed rule (attached) would apply to individuals who reside or own a business licensed or permitted by the board in one of 39 counties. The counties are those that appeared in FEMA disaster declarations and that were impacted by Hurricane Helene.

For affected individuals, the rule would do the following:

Rule Paragraph Paragraph (b), page 2, lines 8-9	Normal practice Electrology licenses expire one year after issuance and must be renewed before the deadline	Changes under the rule Electrologists whose licenses expire between September 1, 2024, and February 28, 2025, would have the license-renewal deadline extended to March 1, 2025
Paragraph (c), page 2, lines 10-12	Individuals who take the apprentice barber exam can receive a temporary permit, but it expires a few weeks after the exam date	Temporary permits would be effective for six months rather than a few weeks
Paragraph (c), page 2, lines 12-15	If an apprentice barber applicant fails the exam twice, he or she cannot receive another temporary permit	Individuals would receive a temporary permit even if they failed the exam twice.
Paragraph (d), page 2, lines 16-18	The time spent working under a temporary permit doesn't count toward the 12-month apprenticeship required to take the licensed barber exam.	The time spent working under these special temporary permits would count toward the 12-month apprenticeship.
Paragraph (e), page 2, lines 19-24	If an individual has held an apprentice barber license for three years (including renewals) without applying to take the licensed barber exam, he or she must submit another apprentice barber exam application and take the written and practical exams.	Individuals whose three years expire between September 1, 2024, and February 28, 2024, can apply to take the licensed barber exam and won't have to retake the apprentice exam. Moreover, the board must issue temporary permits with deadlines of June 30, 2025.

Procedures for adoption

If the board adopts this rule (or a modified version), I will file it with the Codifier of Rules, who will have two business days to review it. If she approves the rule, the rule will be entered into the administrative code and be effective on the sixth business day.
